1. Service Description

- 1) This arrangement between a specific Customer and C&W, provides International Tollfree and Global Tollfree Services at discounted rates.
- 2) Except as set out below, this item is subject to the terms and provisions of Item 402 of this Tariff.

2. Definitions

"Caribbean Band 2" is Antigua & Barbuda, Bermuda, Bonaire, British Virgin Islands, Curaco, Dominica (Commonwealth of), Grenada, Guadeloupe, Jamaica, Martinique, Montserrat, Puerto Rico, St. Kitts & Nevis, St. Lucia, St. Vincent & the Grenadines, Trinidad & Tobago, Turks & Caicos Islands, U.S. Virgin Islands.

"Caribbean Band 3" is Anguilla, Bahamas, Dominican Republic.

"Caribbean Band 4" is Aruba, Haiti, St. Bartholomue.

3. Terms and Conditions

- 1) An initial 12 month contract term applies.
- 2) The Customer must use the Informatics Service exclusively for call centre activities and must employ at least 12 persons that make or receive calls for the purpose of conducting call centre activities.
- 3) The Service must be for inbound call centers only.
- 4) The Customer must not resell, give away, barter or exchange the Informatics Service to any other person.
- 5) Rates and Charges are in \$U.S.
- 6) Usage per month of over 1,000 minutes will be subject to volume discounts ranging from 10% to 25%, depending upon volume.
